Uganda Healing Hub:

In October 2021, we launched a new hub in Mbarara, Uganda which will support community leaders and partner NGOs with mental health care training in the greater East African region. By the end of the year, our team trained 105 community leaders from 11 partner organizations in Uganda and Rwanda to become trauma-informed Healing Advocates, supporting over 1,600 survivors of trauma and violence. The 11 partners included local, national, and global organizations working to empower women and girls and combat sexual and gender based violence.
